**Liquidator's Final Report**

**Mellan Limited (In Liquidation)**  
**(Previously Ellem Limited)**

Gerard Hulst, Chartered Accountant of Auckland, was appointed Liquidator of the above company by an order of the High Court at Auckland on the 29<sup>th</sup> day of June 2000.

**Actions of the Liquidator**

The first report to creditors was dated the 7<sup>th</sup> day of August 2000.

I have followed up all outstanding issues and report as follows:

1. The Shareholder Current Accounts of Leigh KELLY and Marleen HICKMOTT have been collected.
2. The Shareholder Current Account of John HICKMOTT has not been collected as the company was not a LAQC & the draft accounts were incorrect.
3. I have investigated as to whether the company owns any intellectual property and have found that it did not.
4. A review of the accounts revealed that two of the shareholders had received voidable preference payments. This money was repaid.

The liquidation of the company is now complete and the Liquidator states:

## **Notice of Intention to remove Company from the Register**
