# **Liquidator's Final Report**

pursuant to section 257 of the Companies Act 1993

## to the Creditors and Shareholders of

# **B.R.B Holdings Limited (In Liquidation)**

Gerard Hulst was appointed Liquidator of the above company by order of the High Court at Auckland on 7 October 1999.

## **Actions of the Liquidator**

The first report to creditors was dated 10 November 1999.

I have followed up all outstanding issues and report as follows:

- 1. Investigations into the possible recovery of debt from Kase Management have proven fruitless. Kase Management sold the lease and assets of 340 Karangahape Road to Mimosa Holdings Limited.
- 2. Mimosa Holdings Limited was placed into liquidation on 27 May 1999. The Official Assignee was appointed as Liquidator. The Liquidator's first report dated 28 June 1999 stated that the assets of the Mimosa Holdings Limited (In Liquidation) were seized in a police search. The police advised the Liquidator that "the clubs assets were owned by other companies connected with the premises before the involvement of Mimosa Holdings."
- 3. The Liquidator was able to secure some of the company's assets being miscellaneous computer equipment. These assets were sold at auction.
- 4. Colin Brett HUGHES was adjudicated bankrupt on 6 November 2000 and recovery of any debt from him is improbable.
