

**Liquidator's Final Report**

**to the Creditors and Shareholders of**

Gerard Hulst was appointed Liquidator of the above company by order of the High Court at Auckland on the 13<sup>th</sup> day of August 1998.

**Actions of the Liquidator**

The first report to creditors was dated 9 September 1998.

I have followed up all outstanding issues and report as follows:

The Director/Shareholder, Trevor Bingley, had an outstanding current account balance of \$15,184.75. This was referred to our Debt Collection Agency who managed to collect \$3,200.00. The remaining balance is not recoverable owing to the fact that Trevor Keith Bingley was declared bankrupt on the 1 June 2001.

There are no outstanding issues.
