Liquidator's Final Report
pursuant to section 257 of the Companies Act 1993

to the Creditors and Shareholders of

Integrator Plus Corporation Limited (In Liquidation)

Gerard Hulst was appointed Liquidator of the above company by order of the High Court at Auckland on 3 December 1998.

Actions of the Liquidator

The first report to creditors was dated 6 January 1999.

I have followed up all outstanding issues and report as follows:

1. I have received and reviewed the company records and conclude that there are no voidable transactions within the two year specified period.
2. An investigation into the affairs of the company has revealed that as at 31 May 1998 John Younger's shareholder's current account had a debit balance of \$245,308.71
3. Mr. Younger was advised of the detail and agreed with the balance.
4. On 11 June 2002 I deemed \$245,308.71 as a dividend to John Stuart YOUNGER for the year ending 31 March 1999.
5. There is no financial benefit in continuing with the liquidation.

General Comments

The liquidation of the company is now complete and the Liquidator states:

1. All known assets have been disclaimed or realised or distributed without realisation, and
