Petitioning Creditor: The company was placed in Liquidation on the petition

of the Inland Revenue Department for \$61,219.69 being unpaid taxes. Costs of \$1,820.00 plus disbursements of \$485.97 were awarded.

A statement of the company's financial position (assets and liabilities) at the date of liquidation is included with this report.

OBSERVATIONS

The company specialised in Tile Delivery Services and had a good relationship with various tile warehouses as a delivery contact.

The proof of debt filed by the Inland Revenue Department show that the company began having trouble paying its taxes in May 1997.

The Director advised that he first realised "about a year ago" that the company could not pay its debts as they fell due.

Prior to December 2000 the Director went to his financial advisers BDO Spicers.

The eventual outcome is that on the 19th of December 2000 the assets of Tile Delivery Services Ltd were sold to TDS (2000) Ltd for \$38,658. Clause 4 of the agreement states:

Payment of the purchase price shall be on terms agreed between the parties from time to time and failing agreement shall be paid by equal and consecutive monthly, quarterly or yearly instalment's (at the discretion of TDS) over a term of ten (10) years free of interest.

The shareholder and Director of TDS (2000) Ltd is John Allen Mountney the brother of George Mountney.

George Mountney and Ruth Mountney were adjudicated bankrupt on the 17th day of January 2001.

COMPANIES WITH WHICH THE DIRECTORS HAVE AN ASSOCIATION

An internet search of the companies register shows that <u>George Charles MOUNTNEY</u> is not associated with any other companies.

FINANCIAL INFORMATION

The last set of financial accounts for the company were for the year ended 31 March 2000 and were completed by BDO Auckland.

PROPOSALS FOR CONDUCTING THE LIQUIDATION

DISPOSAL OF ASSETS

The sale and purchase agreement between Tile Delivery Services Ltd and TDS 2000 Ltd will need to be reviewed and a repayment scheme arranged.

OTHER ACTIONS OF THE LIQUIDATOR

I will conduct an investigation into the affairs of the company;

- a) To determine the date of insolvency
- b) To determine the conduct of the Directors
- c) To establish whether the directors owe any money to the company and to pursue recovery thereof.
- d) To determine if there are any voidable transactions and to pursue recovery thereof.

ESTIMATED COMPLETION DATE

The administration is expected to be completed by December 2002, subject to any court actions.

PROSPECT OF DIVIDEND

There will be a dividend to preferential creditors.

There will be a no dividend to other unsecured creditors.

NOTICE REGARDING MEETINGS

Having regard to the assets and liabilities of the company, the likely result of the liquidation and other relevant matters, the Liquidator considers in accordance with section 245 of the Companies Act 1993 that no meeting of creditors should be held at this time.

Consequently, a meeting of creditors will not be held unless within 14 days after receiving this notice a creditor gives notice in writing to the Liquidator requiring a meeting to be called.

LIQUIDATION COMMITTEE

At any time during the liquidation, any creditor may in writing request the Liquidator to call a meeting of creditors to consider whether a Liquidation Committee should be appointed, and if so, to choose the members of the committee.

A Liquidation Committee has certain powers set out in s315 of the Companies Act 1993, including to assist the Liquidator as appropriate in the conduct of the liquidation.

In the absence of a liquidation committee, the Liquidator will work closely with the petitioning creditor.
